Welcome

Training-Health, Safety, Nutrition topics with Adrienne Hess, Health & Safety Director; Positive Parenting with Melanie Kuhn, Mental Health Consultant

Adrienne discussed food allergies and the necessary paperwork that we need on file. If an EpiPen is administered, we must call 911. Parents will be notified immediately as well.

Adrienne stated if parents had a child returning for the 25-26 school year that an updated physical and dental exam will be needed. If a child is newly enrolled, families have 90 days from when they start class to turn in these exams. Adrienne discussed that it is difficult to get into pediatric dentists in our area. Primary Care Physicians can complete an oral exam and note in the physical. This meets our requirement. Geisinger dental consent forms will be obtained during the first home visit upon the start of the new year in August.

Adrienne explained that we must have immunization records on file for a child to start class. If a child is behind on immunizations, they must have a catch up plan in place with their Primary Care Physician.

Melanie discussed positive parenting; the power of positive communication; what positive communication is; how to use positive language; types of non-verbal communication; and small shifts equal big results.

Enrollment/Full Enrollment Initiative-We have stopped enrolling preschool children into classrooms, we have less than 30 days left of school. We have started compiling class lists for the 25-26 school year. The administration has been meeting to work out bus transportation, etc. Tabytha discussed that our second change of scope was submitted; we have not yet received approval. We have requested to reduce the number of slots from 454 to 405.

Tabytha shared that girls going into Kindergarten can enroll in Girl Scouts for free over the summer Nothing has come out about Boy Scouts but we will continue to see what we can find.

Tabytha discussed that the Moshannon Valley YMCA will be hosting free movies at our Morgan Run farm over the summer. Flyers will be shared on Class Dojo and events are scheduled.

Tabytha discussed summer movies available at the Ritz Theatre in Clearfield and encouraged parents to attend.

Mason discussed that residents of the Coalport/Irvona area have access to the food bank and \$50 gift cards to Leyo's through the John Lightner Food Bank. You do not need to be enrolled in a CenClear program.

Tabytha encouraged parents to continue advocating for Head Start services. We will continue to share advocating opportunities on Class Dojo.
